These food products must be handled professionally and in accordance with State and Federal food preparation and handling regulations. Stallholders selling food and general beverages such as soft drinks and coffee etc are required to be currently registered under NSW Food Authority and have in place a Food Notification Form for Temporary Events covering off site events.
